#### **ACTION ITEMS**

<u>Approval - Change Chromebooks Funding Source - from PRC 181 to PRC 171 to adjust for the liquidation deadline of September 30 for PRC 171</u>

Ms. McMichael recognized Dr. Perkins for comments regarding the Chromebooks funding source change. Dr. Perkins asked that the funding code be changed from PRC 181 (ESSER III) to PRC 171 (ESSER II). The RCS Technology Department reviewed the submissions and based on the rubric have identified CDW as the winning bid. CDW would provide 2,800 student Chromebooks with licenses and white glove imaging services for \$994,677.88. ESSER funds in PRC 171 would be used for this purchase. This purchase would help liquidate remaining ESSER II (PRC 111) funds.

Ms. McKinney moved that the Board approve the funding source change and purchase of chromebooks as presented by Dr. Perkins. Ms. Alston seconded the motion. The vote was 6/0. Unanimously Approved.

RCS Senior Scholarship Opportunities 2022-2023 - Dr. Cindy Corcoran

Ms. McMichael recognized Dr. Corcoran for the Scholarship Report. Dr. Corcoran reported the total scholarship awards for the 2022-2023 graduates was \$14,481,212. Dr. Corcoran reported the scholarships and awards for the 2022-2023 graduates as listed per each high school. She also provided the historical amounts offered for the previous 16 years.

# Provide update on the ELA Adoption Process - Dr. Charles Perkins

Ms. McMichael recognized Dr. Perkins for his presentation. Dr. Perkins updated the Board on the ELA curriculum adoption process. He stated after hearing five vendor presentations on May 16, 2023, and after a 2-hour discussion with our curriculum review team on May 19, the recommendation was made to bring back 3 vendors for another presentation. Wit & Wisdom/Great Minds, McGraw Hill/Wonders, and SAVAAS were asked back on June 8 for follow up presentations. 24 RCS teachers/staff participated and provided feedback on the curriculum materials. Wit & Wisdom and McGraw Hill were identified as the top choices. The C&I team recommended that we take a slow approach and utilize the Fall semester to create pilot teams across the district to review grade level materials to review and implement the resources on a trial basis. In addition, we have asked the vendors for support in identifying alternative text resources and materials for potential objectionable materials/concepts. Dr. Perkins stated that he would like to bring a recommendation to the Board of Education in December or January for full implementation during the 2024-25 school year. He encouraged the Board of Education members to serve as review team members. Board members asked questions and commented on the information presented.

# Superintendent's Report

Dr. Stover stated that today marks one year and nine days since he started with the district. He thanked the Board for their partnership. We have accomplished a lot this year. Dr. Stover presented his presentation planning for the 2023–2024 school year and beyond (Attachment 5-A). Board members commented on the information presented.

Ms. McMichael announced that kindergarten registration for the 2023–2024 school year is taking place at all of our elementary schools Monday–Thursday.
